I am requesting approval to travel and/or be out of the office June 11-13, 2024, for the USFN Industry Forum in Phoenix, AZ. The event includes 5 general sessions, 22 breakout sessions, several networking opportunities, and meals throughout the three days, all of which are included in my registration rate of \$249. USFN members help offset the cost for servicers to attend with a registration rate of \$1,999. Plus, if I register for this conference early, we can send another team member for free with USFN's 2-for-1 Servicer Offer.

IF TRAVELING TO PHOENIX, AZ:
